ADMISSION PROCEDURE

Eligibility Criteria MCA

- i) The candidate should be a citizen of India ;
- ii) Should have passed any graduation degree (e.g. : B.E. or B. Tech. or B.Sc. or B.Com. or B.A. or B. Voc. or BCA etc.) preferably with Mathematics at 10 + 2 level or at Graduation level and obtained at least fifty percent marks (at least forty five percent. in case of candidates of Reserved Categories, Economically weaker section and persons with disability category belonging to the Maharashtra state) in the qualifying examination;
- iii) should have obtained non zero score in MAH - MCA - CET conducted by the competent Authority.

Second Year (Lateral Entry) Admission :-

Maharashtra State Candidature candidates and All India Candidature Candidates :-

- i) The Candidate should be a citizen of India ;
- ii) The candidate should have passed B. Tech. (Computer Science and Engineering (CSE) or Information Technology (IT) or B.E. (Computer Science and Engineering (CSE) or Information Technology(IT) or Bachelor of Computer Application (BCA) (4 Year)

Eligibility Criteria MBA

Rules & Regulations

RULES & REGULATIONS

1. 75% attendance in the respective lectures/classes is mandatory without which the students may not be allowed to sit for Sessional/ University exams.
2. Use of cell phones indiscriminately on college campus is a punishable offence. Action will be taken against such students.
3. Cycles, two-wheelers of the students & their parents and friends should be parked in the parking zone meant for it.
4. Chewing tobacco, smoking and consuming other Intoxicating material by anybody on college campus is strictly prohibited and is a punishable offence.
5. Spitting, littering and any other kind of unhealthy, dirty, untidy habits must not be practiced by students and their parents during their presence on college campus.
6. The students must follow the instructions given by the office, through due notifications, from time to time regarding - necessary documents, scholarship etc. carefully and submit fill those with the concerning office-assistants. The college will not be responsible for any lapse regarding scholarship documents and they will have to pay (full fees etc) due on them.
 - a. Any student seeking admission in to any course after doing professionally/general courses, will not be eligible for scholarship.
 - b. If the parents have more than two children their wards are not eligible for scholarship.
7. SMS is only a facility provided by the college to the students as a voluntary gesture. No student or parent can demand for it as a mandatory service from the institution.
8. The students must put on their college uniforms every day during college hours. Students of any class without Identity card will not be allowed in the college premises.
9. Any student suffering from contagious and other viral ailments should abstain from coming to the college and must submit application/medical certificate stating the same.
10. Students must submit their projects/assignments and other Internal assessment related tasks regularly otherwise their results will be withheld and due action will be taken by the college authority.
11. Any damage caused to the college property by any student will be compensated by him/her and their parents Immediately.
12. Students of any class must not indulge in ragging form or any form of violent behavior. He/she will not tolerate being ragged or subjected to violence of any kind.
